


A PROFESSIONAL....

The following article is a reprint of a blog posting by Clayton Getz, Drinking Water Operator Trainer with the Kentucky Operator Certification Program. While the blog was written relative to Kentucky operators' it has value for all operators so we felt compelled to share it with you.

What comes to mind when you hear the word, "professional"? Maybe you think of a doctor, nurse, engineer, or teacher. However, as a certified water, wastewater and/or waste operator in the state of Kentucky, you, too, are a professional. Although you might not get the same respect as some of the abovementioned professionals, you

should. A certified water or





agement of solid waste and are required to attend KY agency training and retest every five years to maintain certification. Like a doctor, you hold peoples' lives in your hands if your job is not done

correctly.

When you look at the respect and pay for operators, a few things stand out as reasons why operators have never received the credit that they deserve: the price of water, public knowledge, and self-promotion. There are other causes, but I believe these are the big three.

The price of water is one reason operators do not get comparable pay to other professionals. It has been said many times in our trainings that the water rates have not gone up since that operator has worked for the system. Many facilities that have raised water rates in the last year said it was over 10 years since their last water rate increase. One reason this happens is because people believe water should be free. My response to this is that the water is free, but the treatment and distribution of the water are not.

Public knowledge is very limited on what operators actually do on a daily basis and what affects the cost of our water and wastewater treatment and solid waste management. For example, the public does not know chemical costs have increased by 300% over the last six years. We need to take a new approach to telling our customers what we do. Some of the ways we do this is by doing radio segments on what operators really do or publishing an article in the paper explaining why we flush our lines and the importance of recycling. This way, the public will have more information on why things are being done, and hopefully, lead to fewer complaint

Another issue is that operators typically do not promote their services enough. For example, we have National Water Week every year in May, yet most systems do nothing to promote this event at all. This

would be a great opportunity to let your customers know what you do and why you do it. I have come to the point where I am known as a water nerd. I want to tell everyone what I do. This was exemplified at my ten year high school reunion when I spent 45 minutes explaining to 15 people what water operators do in their careers. The looks on their faces were priceless. No one had a clue there was so much detail to treating water. Most people in your city are the same way, so be proud of what you do. Don't be afraid to say "I am a water, wastewater, or solid waste operator for the Commonwealth of Kentucky." You had to pass a test for this licensure, dedicate long hours of training, listening to me and other agency staff talk and you have earned the right to be proud of what you do. I am proud of every operator out there working hard to deliver safe water to the public, effectively treating our wastewater, and managing our solid waste. Just remember, you are all professionals, and be proud of what you do!
